ANNUAL GENERAL MEETING

Although not as well attended as some years, this was again a very successful meeting.

In her report, the President discussed the continuing Waste Water Disposal Inspection Program, the Open House held by North Frontenac Council in June and the high lake levels over the July 1st Weekend.

The President thanked the Chairs of the various projects; Lynn Young and Carol Shepherdson (Newsletter), Roger Guilbert(Adopt-a-Road), Jean Anne Houle and Carmen Smith (Dinner/Auction) and the Loon Watch Volunteers.

All three amendments to the Constitution passed unanimously. This means that those who are not actually waterfront residents, but who use the lake for recreation and are interested in its stewardship, may apply to become members of KLA.

The second half of the meeting was devoted to presentations by Mayor Ron Maguire and Councillors Fred Perry, Wayne Good (Ward 1), Bud Clayton, Betty Hunter (Ward 2), followed by a Question and Answer period.

The Mayor explained that the Budget had been passed with only a 3% inflation increase from 2005, which is good news for taxpayers. Topics which evoked questions included the Ardoch Algonquin First Nation initiative on Pine Lake, Crown Land Stewardship, the possible expansion on the west end of lake, access docks for Mitchell Island residents and extension of the 479 local calling area.

WRAFT REPORT

(Waterfront Ratepayers After Fair Taxation)

As I reported at our annual meeting in July, the lobbying efforts undertaken by WRAFT and by CAPTR have finally attracted the attention of the Ontario government. Earlier this summer, Finance Minister Greg Sorbara announced a two year moratorium on property assessment increases. What that means for us is that, providing the Township government does not raise taxes, we will not be hit with a property tax increase again until 2009. So this is good news and congratulations should be extended, not only to WRAFT and CAPTR, but to all of you who contacted your MPP, and to the KLA Board of Directors who communicated our collective concerns to our MPP, Leona Dombrowski.

Unfortunately, this is only one small victory in a campaign that is by no means over. It may be that the Liberal government undertook this assessment freeze only for the purpose of shelving a volatile political issue until after the next provincial election in October, 2007. Clearly, a simple assessment freeze is not enough and, unless serious reforms are undertaken, the basic problems with our Current Value Assessment property tax system will still remain when the freeze ends. And those problems are now very obvious, especially to waterfront ratepayers: taxes we pay bear little relationship to the value of the benefits and services we receive from our local government and the taxes levied by the local government have little relationship to our ability to pay those taxes. Without reform, as waterfront properties increase dramatically in value, we will continue to see massive increases in our taxes from year to year.

Consequently, we continue to urge all of our KLA members to keep informed of developments concerning this issue. Check the WRAFT website at www.wraft.com and the CAPTR website at www.captr.org for up-to-date information. Moreover, please continue to contact your MPP and let him or her know that you wish to see a thorough reform of the Current Value Assessment (CVA) system. If you have internet access, an easy way to contact your MPP is to click on the "Contact your MPP" button on the WRAFT website and send an e-mail. Finally, you might wish to consider extending financial support to WRAFT or CAPTR. It is estimated that they will need another \$50,000 to continue their lobbying and media efforts over the next two years. Your Board of Directors voted on making another financial contribution of \$300.00 at our fall meeting, but these organizations would certainly welcome individual contributions as well. Check their websites for names and addresses of persons to contact.

Again, thanks to all of you who took the time to lobby your MPP. The assessment freeze, as modest a victory as it may be, still demonstrates the results that can be achieved when enough of us speak up! m

ELECTION PROFILES

The following are submissions to our Newsletter by the candidates running for Mayor and Council in Wards 1 and 2 (as of Sept. 25, 2006). We hope that these brief notes will help in your voting process.

Bud Clayton - Mayor

Bud has been on Council for 6 years. In the last term he was Chairman of the Waste Management Committee and sat on other Committees and Task Forces such as Personnel and Finance, Waste Water Inspections, Docks, and the Community Police Advisory Committee. He was also Chair of the Waste Diversion Task Force and Vice-Chair of the Pine Meadow Nursing Home Management Board.

If Bud were elected as Mayor, he would:

- Bring into play, long range capital planning
- Put on paper a 5-year Road Plan that considers your concerns
- Freeze hiring of staff
- Hold the line on spending (Taxes)
- Have Crown Land Stewardship Program revenue neutral
- Bring about a more timely budget
- Develop a communication vehicle to keep you more informed

Betty Hunter - Mayor

I have been a councillor for Ward 2 for this term (3 years) but always considered I was representing all of North Frontenac and I want to continue to be part of its future.

As your mayor I will continue to represent North Frontenac with enthusiasm not only locally but on the county level and beyond. I support the provinces mandate that asset management is essential in local government and would push to have it complete as soon as possible so council knows where it is and where it is heading to enable more fiscal responsibility.

I am a strong supporter of the Crown Land Stewardship Program and the strides it has made this term. I am also a strong supporter of economic development and will continue to fight locally for cell phone service and high speed internet for the whole municipality.

The septic reinspection program which was expanded this year to allow more inspections, would be continued and grow. This fall you should also watch for a newsletter to keep you informed. North Frontenac has continued to ask that MPAC show some responsibility in the way it is assessing property values and I would continue to push for a format that shows how they assess real estate.

Fred Perry and Wayne Good - Council, Ward 1
We consider the following initiatives important for
Council during the next four years:

- Council and constituents contact the MPP in their riding to release information during the two year moratorium that MPAC has implemented, and to question MPAC on their new strategies.
- Continue with septic re-inspections in North Frontenac
- Set budgets earlier in the tax year and establish a minimum of two-year rolling budget on major capital and projects
- Apply hold back fees on large developments and sub-divisions to cover future Township expenses i.e. proper infrastructure.
- Continue to work to enhance Waste Management to meet ever increasing government standards, and continue to encourage recycling. Also work with Waste Management in their initiative to establish hazard collection sites for oil filters, batteries etc..
- Fire emergency service continues to enhance training and development of volunteer Fire Fighters. Encourage all residents to become volunteer Fire Fighters. Continue to develop post disaster plan. Continue to pursue standardization of all fire equipment in Fire Halls in N. Frontenac.

- Work with ambulance service to relocate the ambulance base to a more controlled location, probably Plevna.
- Publish to all contractors that their customers are required to have proper building permits, set backs and Mississippi Valley Conservation approvals, when disturbing the waterfront.
- Continue to monitor taxes to the required level to provide the proper services and maintenance to the level expected by the taxpayers of North Frontenac.

LAKE STEWARDSHIP

An official letter was sent to Mississippi Valley Conservation from KLA registering our official dissatisfaction with the handling of water levels on Kashwakamak over the July 1st Weekend. Heavy rainfall, failure of the MVC automatic gauge, fallacious level assumptions and failure to call me for back up information led to the high water levels which we all experienced

Ironically, we received very little rain from then until September - 15.5mm (July); 19.0mm (Aug) - barely an inch of rain in two months. The low lake level and the stressed trees were a testament to that! Thankfully September seems to be making up for it!

New Lake Steward

I would like to thank all those who volunteered to take over as Lake Steward next year. Guy Nason has been appointed to the position. Although not a full time resident, Guy is at the lake often enough between spring and fall to carry out the various sampling and testing required. I congratulate Guy and I will give him all the information and help in any way I can. Guy will be taking the early spring samples for phosphorus analysis and will continue the Lake Partner Program with M of E and invasive species sampling with Mississippi Valley Conservation. I will continue to monitor lake levels and rainfall for MVC.

Is the Ice Safe

If you are at the lake this winter you may wish to walk, skate, ice fish or snowmobile on the lake. How do you determine whether or not the ice is safe? With our recent milder winters this is always a concern. The Ontario Snowmobile Safety Committee has provided the following guidelines as measured in clear hard ice:

3" (7cm) or less	STAY OFF
4" (10cm)	Ice fishing, walking or
	cross country skiing
5" (12cm)	One Snowmobile or ATV
8-12" (20-30cm)	One car
12-15" (30-38cm)	One medium truck

AVOID: Slushy ice, ice near moving water, ice that has thawed and refrozen, and layered or "rotten" ice caused by sudden temperature changes.

Evaluate the ice before you travel on it. Remember no ice is without some risk – minimize YOUR risk Be Safe! (From The Shield, Jan. 13, 2006)
