WASTE WATER DISPOSAL SYSTEM INSPECTION

In the second year (2006) of this septic program, 102 sites were inspected; 73 were on Kashwakamak and the others were on Mazinaw (7), Big Gull (17) and Marble (5). In the interests of efficiency, it was attempted to group inspections by road. In this way more interest in the program was created and people did not feel they had been singled out.

Unfortunately, the initial letters advising owners that their sites had been selected for inspection were not mailed.

This presented somewhat of a challenge when doing the inspections. Opening up the tank is considered highly invasive and only done with the owner's permission. Since no questionnaires were sent out, there was no opportunity for owners to give their permission. Therefore in the majority of the sites only visual inspections could be done. The tank was only opened if the owner was present and gave permission.

A visual inspection can identify problem situations, such as being too close to a well or the lake, surface discharge, wet areas and trees or roots on the septic bed. While this is valuable information, visual-only inspections made it impossible to collect accurate data on the condition of the tanks, baffles *etc*.

The results of the sites inspected on Kashwakamak:

Properties which were considered a significant threat to the environment or health were forwarded to the Kingston Frontenac Lennox &Addington Health Unit for enforcement.

All owners involved in the 2006 Program were sent a package that included:

- An apology from North Frontenac regarding lack of notification
- An individual report for each property detailing any questions or concerns (or lack thereof).

I would like to thank all our members who were part of the 2006 Program for your support and cooperation in difficult circumstances. This program will continue in 2007 on Kashwakamak and the neighbouring lakes.

PROPERTY TAX REFORM UPDATE

Thank you to all who responded to our call for action in January. It did achieve some action by the government – unfortunately not enough!

The 4-year assessment cycle as described by MPP Leona Dombrowsky in her reply (enclosed) to a letter from KLA does not deal with the volatility of the assessments or the unfairness of the process. There is nothing in the Budget that will prevent a return to dramatic double-digit increases in property assessments. When they resume in 2008, you will just have four years to deal with the heavy tax impact. Then the next assessment notice will arrive.

The Coalition after Property Tax Reform or CAPTR (of which we, through WRAFT {Waterfront Ratepayers after Fair Taxation} are members) represents more than one million Ontario property owners. CAPTR believes that assessment hikes must be limited to no more than 5% annually. Otherwise, the combination of hot real estate markets in some areas and a crude assessment methodology will continue to lead to massive volatility in valuation and property taxes. The figure of 5% annual cap was chosen because it is the long term average increase in residential property values. It is a fair and realistic cap which will allow assessments to rise in line with past trends. An assessment cap is revenue neutral to both the municipalities and the province. It does not cap taxes – only the volatility of their distribution amongst property owners.

The provincial election is just over 3 months away (October 10). The promise the McGuinty government made in 2004 to fix the assessment and property tax has not been fulfilled.

The PC Party have announced a 5% cap on annual assessment increases as part of their election platform. The New Democrats have also recognized the need to end the unfairness of the present system. (See p.26 of the June 2007 issue of *Cottage Life* magazine which grades the policies of the political parties).

Water Quality Results 2006

Clarity readings are taken at least eight times throughout the summer. In May, lake water samples are taken, which are sent to the MOE for phosphorus analysis. The results from 2006 were excellent – time will tell whether this was just one good year or a positive trend.

LAKE STEWARD'S REPORT

At last year's Annual Meeting, I agreed to replace Elma MacLachlan as Kashwakamak Lake Steward. Elma has conducted the duties of Lake Steward in an exemplary manner for more than ten years and certainly deserves a break. Thank you, Elma. I hope I can live up to your high standard.

First, an introduction. My name is Guy Nason and I'm a relative newcomer to the lake. My wife and I bought an undeveloped lot on the north side of Michell Bay ten years ago. The cottage went up about five years later. Our permanent residence is in Toronto, but we spend as much time at the lake as possible.

When we went shopping for cottage property back in the 1990's, we were attracted to northern Frontenac County by its lakes and skies. As enthusiastic paddlers, we wanted a place where we could put our canoe (and later, kayaks) in the water and paddle happily to – well, almost anywhere the urge took us. As an active amateur astronomer, I was taken by the incredibly clear, dark skies above The Land O' Lakes. When we found a few acres of undeveloped land on Kashwakamak Lake with lots of shoreline and a nice little hill on which to build an observatory, we knew we were here to stay.

For the last decade I've told anyone who would listen how great our lake and its environs are. Now, putting a bit of time and effort where my mouth is, I agreed to become Kashwakamak Lake Steward.

As part of the Lake Partnership Program, I'll be working with the Ministry of the Environment by taking annual water samples to monitor total phosphorus content, and to frequently measure the transparency and temperature of the lake. I'll also connect with the Mississippi Valley Conservation Authority and FOCA to assist with, and keep you informed of, their initiatives. Two such areas of interest are the prevention of aquatic invasive species and shoreline stewardship. I'll address the former here and the latter in a separate article elsewhere in this issue.

Invasive Species Prevention:

Invasive aquatic species are non-native organisms that have entered local watersheds, usually as a re-

sult of human activity, and often compete aggressively for nutrients to the detriment of native species. They include plants like fanwort and purple loosestrife, and animals such as zebra mussels and spiny water fleas. Although Kashwakamak Lake did show evidence of zebra mussels in the past, recent sampling has detected none. Last year MVCA surveyed the lake looking for zebra mussels and spiny water fleas and detected neither.

Zebra mussels (molluscs) and spiny water fleas (small crustaceans) have been detected in the Great Lakes and some inland Ontario lakes since the 1980's. Both compete for food directly with small native fish. A decrease in small fish populations could also take away a food source for larger sport fish. In addition, zebra mussels emit phosphorus, a nutrient that contributes to lake-killing algae blooms. Once established, zebra mussels proliferate rapidly and can cover nearly anything in the water, including boats, anchors, water intake pipes and even other species. Fortunately, Kashwakamak Lake seems to be free from such ecosystem-altering interlopers. Let's all try very hard to keep it that way.

The single best method of preventing aquatic species invasion is to practice good boat hygiene. Boaters who use their craft in more than one body of water are the prime agents for aquatic species migration by offering free rides to these pests. Immediately upon taking your craft out of the water, spray down the boat and trailer, and drain all standing water in the boat, including bilges and livewells. Spray off all your fishing gear, anchors, downriggers and anything else that has been immersed in the lake. Don't wait until you're about to re-launch into a different lake. Doing so would simply wash hitch-hiking organisms into the new lake - exacerbating, rather than preventing, the problem. Use high pressure or hot water when hosing down the boat and trailer or keep them high and dry for at least five sunny days before re-launching.

GOOD SHORELINE STEWARDSHIP

One of the most effective ways to promote a healthy lake is to practice good shoreline stewardship. A natural shoreline resists erosion, reduces pollutants, and provides spawning grounds and protective habitat for fish and other wildlife. It's also a place for aquatic plants, "the lungs of the lake", to do their job of releasing oxygen into the water and converting sunlight into food.

If you are considering making changes to your shoreline, be sure to take a low-impact approach. Consider floating or cantilever docks, for instance, instead of a fixed dock. Or limit alterations to less than 25 percent of your shoreline.

If your shore is "unnatural" with, for instance, a concrete retaining wall or a lawn that extends to the waterline, you might consider restoring at least part of it to its natural state. That need not be expensive or time-consuming - quite the opposite, in fact. You will save money by not applying pesticides or fertilizer to your lawn and by not mowing the last few metres of lawn you will get more hammock time while allowing native plants to re-colonize the shoreline. Logs and other natural detritus that fall near or in the lake should be left where they lie. Here's one case where it's good to be lazy! If removing some or all of a concrete retaining wall is not feasible, then reworking the shoreline immediately above and below the wall will help.

These measures will help to improve the health of the lake. Besides, it's the law!

Canada's *Fisheries Act* assigns the Department of Fisheries and Oceans (DFO) the responsibility to administer and enforce the conservation and protection of fish habitat and applies to the whole of Canada, including private property in every province and territory.

Anyone considering any change to the shoreline would be wise to approach the DFO first. According to the DFO's website, "you are within your legal rights to go ahead with your project without having it reviewed. But if you do, and if you harm fish habitat you are liable to prosecution under the *Fisheries Act*." And that can be very expensive!

Other environmental stakeholders should be contacted as well, particularly the Ontario Ministry of Natural Resources (www.mnr.gov.on.ca) and the North Frontenac township office (www.northfrontenac.ca or phone 613-479-2231).

One more thing: A major way that all of us – not just waterfront owners – can help prevent shoreline erosion is to obey the boating laws, especially the near-shore speed limit: 10 kph (~6 mph) within 30 metres (100 feet) of shore. This applies everywhere, not just where it's posted.

Together we can keep our lake healthy! 🗯

REMINDERS

- No burning of brush between 7:00am and 7:00pm from April 1 To October 31
- Be aware of when "Fire Bans" are in effect. Be especially careful of lit cigarettes!
- Building permits are required for additions, auxiliary buildings *etc*. Check with Dave Young, the North Frontenac Building Inspector, if you are in doubt as to whether you need a permit.
- Permission is required for any work that alters the shoreline, such as removing driftwood, docks, retaining walls, boathouses etc. Apply to MNR at their Bancroft office.
- Do use phosphate-free cleaning products Read The Labels!
- **Do Not** fertilize grass near the lake.
- Everyone will require a Boat Operator's license by September 2009
