#### MEMBERSHIP REPORT

Membership in the Kashwakamak Lake Association now stands at 385 families, a slight increase over last year at this time.

The thrust this summer and fall is to move substantially into the electronic age, with our first real attempt at sending out the Fall Newsletter by e-mail to all those members willing to give this approach a trial run. During the summer we have been canvassing members to obtain their agreement to participate. Recently I have used e-mail addresses on my file to contact as many members as possible. I am pleased to report that as I write this article, of the 234 members with an e-mail address, 73% have agreed to an e-mail delivered Newsletter; 13% declined the offer for a variety of reasons, and 14% have yet to reply. As a member of the group that buys materials, stamps, makes photocopies, prints out address labels, stuffs envelopes and delivers the packages to the post office, I deeply thank those who have agreed to participate in the e-mail approach.

I have received some feedback regarding the security and use of the e-mail addresses we now have on file. Let me emphasize that it is the policy of the KLA to limit the use of these addresses to KLA business only. We use the addresses to inform our members of issues and items of interest regarding our Lake (a mailing of such information would be too time consuming and expensive), and now to send out Newsletters (although the Spring Newsletter may still be mailed out to all members). It is hoped that of the 151 members without an e-mail address on our file, some may now choose to supply their address given their restricted use.

In closing, I would like to mention a very recent situation where the e-mail addresses were very useful. I received an e-mail message while travelling in the Maritimes concerning a break-in at one of the cottages on the lake. I was able to look up the 911 addresses on my membership file, and send out e-mails to all owners with cottages in close proximity to the break-in within an hour after I read the e-mail. The importance of ensuring that all your information (home & cottage addresses and phone numbers, and e-mail addresses) is up-to-date cannot be over-emphasized. Unfortunately, 7% of the email requests (in respect to the Fall Newsletter) that I sent out recently came back with invalid e-mail addresses.  $\infty$ Allen Archibald Membership Chairman

### WOODCREST TRAILER PARK UPDATE

The Ministry of the Environment have signed off (with some conditions) that the Sewage System and Water Supply at Woodcrest is adequate for a 200 site expan-

sion. The Township Planner has now asked Woodcrest to provide a more detailed site plan, drawn up by a professional. This is still pending.

When the Planner is satisfied that all conditions provided for in the Official Plan have been met, a "Site Plan Agreement" will be written including these conditions. Woodcrest has to "agree" to this.

The matter will then go to the Committee of Adjustment (which is made up of non-Council members and is chaired by Brenda Defosse, Clerk and Planning Coordinator), who will study all the related documents and make their recommendations to Council.

The Site Plan Agreement is not subject to any public input, but, at this point, the Executive Board of KLA has officially requested that Council ask for an Environmental Impact Study (EIS) on the Woodcrest Expansion Application.

This was brought to the September 24<sup>th</sup>, 2009 Meeting of Council. After some discussion, our request was deferred until after a satisfactory site plan would be received from Woodcrest.

It is not KLA's desire to stop Woodcrest from expanding their trailer park, but, in the interests of all, we would like to ensure that the expansion would not jeopardize the lake environment, either now or in the future.

# Garbage and Recycling

Our initial reports are that the Clear Bag Policy for Garbage implemented this summer by the municipality is increasing the percentage of recycled material and reducing the amount of garbage. Thanks to all for your cooperation.

The Township has recently purchased a 'compactor', which will be moved from site to site to further compress the garbage.

# Septic Re-inspections

Inspections have been carried out over the summer. Unfortunately, our enthusiastic inspector, Jamie Saunders, has resigned to return to his home town of Thunder Bay and a new position there. We wish him well! Eric Kohlsmith, his replacement, will complete the inspections and write the reports.

Our Health Inspector, Brian Black, has retired. His replacement is Andrew Girrouard, who will also be working out of the KFL&A Health Office in Cloyne.

# Official Plan

The latest proposed changes to the Draft Official Plan will be presented at a Public Meeting to be held on Thursday, October 22nd, 2009, at 7:00 pm upstairs in the Clar-Millar Fire Hall (behind the Township Office on #506).

The 5-year mandatory Review of the Official Plan will be completed this year. Public input is encouraged, either by presenting a submission at the meeting or by email, Fax, or by written submission to Brenda Defosse, Township Clerk. # **Broadband Update**

North Frontenac Township is pushing ahead with the Broadband Program, having received a grant of \$335.000 from the Province, which is approximately one-third of the total cost. Frontenac County and the service contractor (Omniglobe) will provide the remaining two-thirds. Actionable Intelligence (Ottawa) is overseeing the project for the Township.

The main tower, between Big Gull and Kashwakamak, is scheduled to go up this Fall, with repeater towers being erected throughout the region in the Spring.

On a preliminary assessment, the south shore of Kash should be pretty well covered, but the service on the

north shore, especially on the east end, may be more "hit or miss". So much depends on location, terrain and tree cover, that only after the towers are up, will we know for sure who will be able to receive the service.

### KASHWAKAMAK?

Do you know what the name "Kashwakamak" means?

When a member asked me this question, I realized that I had no idea - I'd always thought it meant "Long Lake", but this was just a familiar name by which the local residents called the lake.

I asked Chief Perry of the Ardoch Algonquins to look up the meaning for me. It comes from three Algonquin words:

"kash" means "jagged"; "awak" means "all around (the bottom)"; "amik"(amak) means "beaver" or "body of water".

So translated loosely, it would mean "the lake with rocky shoals". For the native peoples, this would have been an identifying feature to distinguish it from all the other lakes in the area. In the old days, when the lake was lower than it is today, rocks would have been more of a hazard.

### LAKE STEWARD'S REPORT


My goodness, where did summertime go? I hope you enjoyed your time on the lake, despite the persistently poor weather. Personally, my lake-time really was short because of an unusual amount of travel outside the province. As a result, my lake sampling routine was curtailed somewhat. Normally, I take the lake's temperature and measure its transparency every two weeks. So far in 2009, I've only managed a rate or about once per month. However, that's enough for an interim report. So far, the lake has been a bit cooler and somewhat less transparent than in the past few years. I shall report the exact figures after the conclusion of the sampling period in October and will publish them in *Kash Kourier* next spring.

Some of you may have noticed new "Stop" signs posted at boat launch sites and resorts on the lake. This is part of our efforts to promote "good boat hygiene". The single most effective thing we can do to prevent the introduction of invasive species is to clean our boats and water toys as soon as we remove them from the lake. The "Stop" signs outline how best to do this, but essentially, it's just a matter of carefully washing down the boat, trailer, downriggers, etc. when removing them from the water. Do this at the point of egress, rather than just before launching the boat, so that any contaminants you may have picked up are returned to the source, not transported to the new location. Another effective strategy is to keep the boat and trailer high and dry (emphasis on "dry") for at least five consecutive days.

Back in 2003 there was some evidence for the presence of zebra mussels and spiny water fleas in our lake, but not since -until last year (the most recent year that samplings for invasive species were taken). Mississippi Valley Conservation

[www.mvc.on.ca] wrote: "Kashwakamak Lake was ... tested for invasive species in 2008, in particular, for zebra mussels
and spiny water flea, in partnership with the Ontario Federation of Anglers and Hunters. Kashwakamak Lake did *not* have
zebra mussel veligers (larvae) present; however, spiny water fleas were detected in the samples collected."

What are spiny water fleas and why are they a problem? According to the Great Lakes Information Network (<a href="http://www.great-lakes.net">http://www.great-lakes.net</a>), "the spiny water flea (Bythotrephes cederstroemi), or "B.C.," is a tiny (less than half an inch



long) crustacean with a long, sharp, barbed tail spine. A native of Great Britain and northern Europe east to the Caspian Sea, the animal was first found in Lake Huron in 1984-probably imported in the ballast water of a trans-oceanic freighter. Since then, populations have exploded and the animal can now be found throughout Great Lakes and in some inland lakes.

"No one is really sure what effect spiny water fleas will have on the ecosystems of the Great Lakes region. But resource managers are worried, because the animals may compete directly with young perch and other small fish for food, such as "Daphnia" zooplankton.

"Spiny water fleas also reproduce rapidly. During warm summer conditions each female can produce up to 10 offspring every two weeks. As temperatures drop in the fall, eggs are produced that can lie dormant all winter.

"High numbers would not pose a problem if spiny water fleas were heavily consumed by predators. But its sharp spine makes it extremely hard for small fish to eat, leaving only some large fish to feed on them. As a result, spiny water flea populations remain high while populations of plankton, which they eat, have declined."

How did they get into Kashwakamak Lake? MVC also tested Mazinaw and Marble Lakes last year and found no evidence for the presence of either zebra mussels or spiny water fleas there. So they didn't simply wash downstream to us, but were probably introduced directly into our lake by human activity. To minimize further contamination by this and other species, please remember to clean your boat, trailer, bait buckets, bilge tanks and live-wells carefully.


