**Lake Kashwakamak Surveys Completed**

As you may recall from our last report, the Kashwakamak Lake Association (KLA) approved the initial phase of a Lake Sustainability Planning process in July 2011. The Kashwakamak Lake Sustainability Planning committee moved ahead to the next step in the process and sought feedback from the community through a survey. The key purpose of the survey was to find out what people value about the lake community and what their issues are.

The survey ran from late summer to the end of 2011 and we received 170 responses. The committee was very happy with the number of responses, but found that there were only 2 businesses that responded to the survey.

Membership decreased slightly over the past year, and is now at 385 members (loss of 6 members overall). This includes 93 members from the South Shore Road Association; 20 members from the Silver Mine Road Association and 21 members from the Kashwakamak Cottage Association, who pay their membership dues through their association.

The decrease in membership has more to do with members who have moved or sold their cottage to a non-family member. As it is difficult for the Board to keep up with these events, we ask the membership to speak with the new cottage owner on our behalf and ask them to contact the KLA regarding membership.

## E-mail Communication

Our efforts to expand our e-mail communication with the members

continue, with a total of 35 messages sent out in 2011 and a further 10 messages so far this year.

These messages have included:

- monthly Elerts from FOCA;
- Watershed Bulletins from Mississippi Valley Authority;
- reminders of scheduled KLA events;
- notices of community presentations, talks and workshops provided by local authorities;
- DND training exercises in the local area;
- information to keep you informed about the provincial election;
- the slow evolution of high speed internet;
- the status of water levels in spring and fall; and,
- lost & found swimming docks and rafts.

Our e-mail capable members now number 286 (increase of 14 over 2011) or 74% of the total membership. In addition, we can also send e-mails to family members, which added another 66 people (versus 58 in 2011) who receive KLA related news. We respect the fact that some members are still using dial-up, and if

we are aware of their transmission speed, we do not send them large files. We leave it to you to make sure we know that you use dial-up.

## Keep your email up to date!

Unfortunately, there are some e-mail addresses that are no longer valid, either temporarily or permanently. Time does not permit us to phone members to check e-mail address, and so please let us know of any changes. If you haven't received any e-mails from the KLA for a period of time, chances are we no longer have a valid address for you.

Please remember that we treat your information with respect and confidentiality. We do not release e-mail addresses to anyone, but do share e-mail addresses with your road association to try to keep our mutual lists up-to-date. We use your e-mail address to send out information that is relevant to our cottages and life on the lake.

# Lake Steward's Report - Spring 2012 - Milt Houle

We all know it was an unusually warm winter and early spring. Ice was gone from Kashwakamak Lake by mid March while normal ice-out takes place in mid April. As a result, the dam was closed early to catch the spring run-off and our lake was almost at full level by Easter weekend, April 7 - 8.

## Testing Water Depth

Water samples were taken and the first Secchi disc test was done on April 30th. The depth was poor at only about 4.27 m (14 feet) and the water temperature was 10 C (50 F). The second Secchi disc was taken on May 19 and the depth was 6.2 meters (about 20 feet) and the temperature was 18 C (64 F).

## Testing Water Clarity

The Secchi disc is lowered into the lake at areas specified by the Mississippi Valley Conservation Authority where the water is about 15 meters (50 feet) deep. When the Secchi disc can no longer be seen by eye the depth is documented on a chart. This measures the clarity of the water at that particular point. The average reading taken over time is in the 5.5 meter range (18 feet) and our lake continues to be very consistent year to year. These tests determine the phosphorus, algae content and natural elements in the lake.

On another note, the recent logging at the end of Kashwakamak Lake Road, at the south east end of the lake, ended in mid-January and future logging depends on the pulp mill in Trenton, as it has threatened to close down.

Look after our lake, over-use of septic systems should be avoided. Install an outside shower - they're great.

# Treasurer's Report - Allen Archibald

Included in this Newsletter mailing is the audited Financial Statement of the Association for 2011, together with notes providing background to the numbers.

The cash balance decreased by \$536.39. This occurred primarily as a result of one payment due in 2011 for \$1,395, but was not received until early 2012. The expenses associated with the two Newsletters (Spring & Fall) were significantly decreased as the effect of e-mail mailings instead of normal printing and mailing

were realized for the full year. The second annual Family Day still did not break even, losing \$286 for this very popular and successful event. The tinkering in relation to the cost and fee structure continues with the objective still to break even.

The policy of your Board is that all monies received from the Silent Auction (held at the annual KLA dinner) are given to a Charity. Over the past couple of years the collection and then payment of these monies has not occurred in the same calendar year. We will attempt again to resolve this

situation fully in 2012.

All other costs and revenues are in line with the normal functioning of the Association.

Please remember to pay your annual KLA dues which will be gladly accepted by mail now or in cash or cheque at the AGM which will be in Harlowe on Saturday, July 14<sup>th</sup>.

## NEW: Pay your KLA Fees Electronically!

In response to many members' comments, considerable effort has been made to establish a process whereby KLA members paying fees directly to the KLA (and not through a Road Association) can do so electronically.

We would like to announce that such a process is now in place, through the Interac e-mail transfer protocol.

For those who have used Interac before, these instructions will be familiar. For those unfamiliar with Interac, I would suggest that you ask a friend, relative, or your bank for help in setting up this type of payment.

Banks will charge a fee for this transaction – typically \$1.00 to \$1.50, although some personal accounts provide a few free transactions a month. Any cost would be offset with savings of stamps, envelopes and time.

Of course, should you wish to continue mailing your cheque, we will be pleased to accept it.



## An Update about Internet service in "Cottage Country"

If you could check email and access the Internet at the cottage, would you be able to extend your stays by a day or two? What if you live permanently in rural Ontario? A lack of Internet service has limited the ability of rural residents to access many important online services, to stay in touch with family and friends, and to establish or operate businesses in cottage country.

**FOCA is very excited to share some good news with you: there have been recent developments that will make it easier for you to have Internet at your rural property.**

Thanks to the growing network of land-based and satellite options, you can now get improved Internet access, higher speeds and greater bandwidth, as well as lower costs for Eastern Ontario thanks to the **Eastern Ontario Regional Network**, or EORN. **Developed by the Eastern Ontario Warden's Caucus, the regional broadband project is focused on building a network that will provide high-speed Internet access to 95 per cent of the region by 2014.**

Fixed wireless service is available in some communities, while satellite service can reach more remote regions, provided tall trees or terrain do not interfere with the signal. Satellite is the best fit for the most remote regions.

Take a look, below, at the range of services being offered by our corporate sponsor, **Xplornet**. Aside from satellite service, Xplornet also includes up to 10 Mbps speeds and 100 GB of bandwidth on fixed wireless for very competitive pricing.

And get ready to surf at the cottage!

## About EORN:

The Eastern Ontario Regional broadband Network (EORN) is a \$170 million project led by the thirteen municipalities that make up the Eastern Ontario Wardens' Caucus representing more than 1 million people across the region, and is funded by federal, provincial and municipal governments and private sector investment.



Work to build a massive, 5,500-km fibre optic network is already underway. EORN is a not-for-profit organization established by the EOWC to manage all contracts awarded as part of the project.

We are making excellent progress in building a new regional network that will allow our residents and businesses to prosper," said Dave Burton, Chair of EORN. "Connecting to the Internet with higher speeds will open new doors for our communities in terms of quality of life and economic growth," added Mel Campbell, Chair of the EOWC.

## Local Business An Essential Part

As in other lake sustainability planning processes, the committee sees businesses as an essential part of the community and we wanted to ensure their feedback and views are included. After some discussion with community business leaders, the committee formed a list of businesses to interview.

In total we interviewed over 30 business owners by telephone in order to understand why they value the Kashwakamak lake community and what their concerns are. One message was very clear from talking with so many business owners – the need for permanent residents, cottagers, and visitors to be customers for their business. Several owners cited concerns that people are going to larger centers to shop, which doesn't help the local community. They make a good point.

Several studies have shown that money spent at businesses where the ownership is local has a large impact on the wealth of the community. One study states that money earned by a local business owner is spent within the community two more times.

For example, when a local construction company gets paid for a renovation on a cottage, the business owner typically buys the renovation material from locally owned building supply stores. The money earned by the building supply stores not only pays for employees, but also pays municipal taxes, which helps share the municipal tax load on residents. If the employees of the building supply stores then buy their groceries locally, the grocery store provides jobs, pays taxes and a local service for the community. In short, supporting local business is important for all of us.

The Lake Sustainability Planning process has several steps to it. The first step is research and surveys. This is an important aspect

of this work as it engages the community in discussing their concerns and what they care about. Without this step, a Lake Sustainability Plan is just a plan made up with a hand full of people in a room.

## Survey Results To Be Shared At AGM

The committee will be sharing the results of the survey in person at several points throughout the summer. The full details of the community and business surveys will be presented first at the KLA Annual General Meeting on July 14<sup>th</sup> at the Harlowe Town Hall from 9:30 to 11:30 am. ## North Frontenac Council News

There has been a significant upgrade to the **GIS and Maps section** of the NF Council website, [www.northfrontenac.com](http://www.northfrontenac.com). It not only has information about land parcels, zoning etc. but now has **2011 Census information** including data about population growth in the township.

It also has a section called **North Frontenac Parklands** showing campsites, boat launches etc. There is a section on the **Schooner Trail** which is North Frontenac Parklands first official trail. There are demo videos on both of these sites which might be interesting to some of our readers.

There is also a new brochure available on the website called **Important Info on Private**

**Lanes.** It provides information about residents' responsibilities with regard to private lanes and roadways that are not maintained by the township. It talks about the importance of properly maintaining private roads to provide access for emergency vehicles and outlines recommended minimum standards for road surfaces, overhead clearance and turn around space at the end of the road/lane.


