Lake Sustainability Planning - Survey Results Highlighted at 2012 AGM

There was lots of positive feedback and interaction from the KLA members and quests in attendance nect residents and cottagers with Association (KLA) Annual General Meeting held in Harlowe. One long time lake resident and KLA member commented, "It was the best AGM I've been too. The information that Scott Bennett shared was very interesting and helped me understand the lake sustainability process better," she explained.

Two or three people also stood up to thank the Lake Sustainability Planning Committee, a group of KLA volunteers, for their hard work and for pulling together the community and getting the feedback. "You're on the right track," one member said.

In the Q & A session most of the questions focussed on how to interpret the survey results. Several people also shared challenges with finding a local business for their

needs, and there was a discussion around the best ways to help conat the July 14th Kashwakamak Lake businesses in the community. Scott also reminded people of the importance of community engagement in a Lake Sustainability Plan so it reflects the interests and concerns of the broad community and not special interests.

On Kashwakamak we are lucky enough to have most water hazards marked. I did hear of an incident this year where at the west

end, shoal markers using propane tanks as markers were removed. The Federation of Ontario Cottagers' Associations (FOCA) website has information

and links to advise what markers are acceptable and explains liabilities to persons marking hazards. http://www.foca.on.ca/ontario-boating-regulations . My hopes are common sense and Good Samaritan's prevail.

Remember, as members of the Kashwakamak Lake Association (KLA) you are also a member of FOCA. The FOCA website contains other important information and links to relevant websites that cottagers should find helpful and informative.

Your KLA board has been busy this cottage season and I am happy to say has received some new volunteers to help us accomplish the goals of our association. Joining the board are Andrew Blake of the South Shore and Don Cory of Whitefish Bay. We are still

looking for representation from the Weiss Point area and encourage interested parties to contact any board member listed in this publication and on our website www.kashwakamak.ca. We are a diverse bunch of goal oriented, fun loving cottagers who are making a difference for generations to come. We need young people. Look around the cottage and get your next generation Kash lovers and future stake holders to put their hand up and make a difference!

Some members vocalized concerns to board members about the OPP and specifically its policing of the lake and surrounding areas. I mentioned at the AGM that the board was having a meeting with them to gain a better understanding of what their take on policing was. The meeting was very informative and gave the board better insight while establishing communication lines.

We have asked for statistics and policies on enforcement and expressed concerns over boat washing by the OPP when transferring from lake to lake. Most of the questions posed were answered then or in a follow up email. Statistics we are still waiting for. As it was explained, the OPP are obligated to respond to complaints or concerns of residents, boaters etc. There are three different possible responders within the OPP: the regular patrol officers, the marine unit or the S.A.V.E. unit. (S.A.V.E acronym for Snowmobile, ATV, Vessel Enforcement). It was explained that the SAVE unit is enforcing the laws without much leniency and with the OPP or regular patrol officers, it was at the officer's discretion. Space in this newsletter does not allow me to expand on all conversations. I encourage

you to become aware of all of the obligations, requirements and regulations for operating vessels, snowmobiles and ATV's. Be sure to explain them to other users at your cottage to avoid unhappy outcomes.

One important item brought forward by the OPP was having cottager contact information. The example brought forward was break-ins that occurred on another lake which resulted in the perpetrator using one cottage they entered as the storage place for items obtained from various other cottages. When the culprit was arrested the OPP had no way to contact the cottage owners (some out of country owners) as the 911 numbers do not provide this information. The OPP has requested, for our membership's benefit, that KLA provide them with a list of the 911 numbers and the name, permanent address and phone number of the property owner. Having this information will allow them to reach you if situations like this arise. Please let us know if you do not want your information shared with the OPP for some reason by sending an email to that effect.

We had another successful Family Day thanks to the many board members, volunteers, Fernleigh Lodge and the many local businesses and individuals who donated generously to our success. It was a fun day attended by Mayor Bud Clayton and deputy mayor Fred Perry. The Township of North Frontenac also brought in the fire department with three members and two response vehicles to educate and thrill the crowd. MVC had three of their staff come and offer pamphlets and hands on education including an information booth and hands on water sam-

Lake Steward's Report - October 2012 - Milt Houle

As most of you know, the ice was gone in mid March this spring. This is about one month earlier than usual and it had an affect on my water tests that are always started the first week of May.

The first two Secchi readings for clarity were 4 meters and 6.2 meters. But as the season progressed, the readings became more normal, averaging 5.1 meters as of September 1st. This is fairly consistent with the last few years.

Loon Watch - Please Report Loon Sightings!

Please include the location, date, approximate time and details, i.e. parent and baby. We have a sense that the loon population is increasing on our lake and this information will help us track this and follow the change from year to year.



LOON Q&A – Did you know …?

Can the waves in the wake of a speedboat disrupt loon nests? By Jackie Davis, Cottage Life Magazine

The Answer

They sure can (unfortunately). And they can drive loons off your lake permanently: If boat wake is constantly swamping or destroying nests, the loons may abandon the nesting site. That's why it's a good idea to steer clear of known nesting areas, plus boat slowly close to the shoreline $-10~\mathrm{km/h}$ or less within 30 metres of shore. This helps preserve other wildlife habitats, prevents erosion, and keeps your lake neighbours from getting irritated with you. (It's also the law on most Ontario lakes.)

But, wait, let's not pick on the powerboats; other watercraft—PWCs, plus canoes or slow-moving small boats that access shallow water—can disturb loons and nests too. It's helpful to know the signs of a stressed-out loon, so you can back off, ASAP: For example, a loon vocalizing at you, or splashing across the water. This means "Get out of my face!"

Where Are We??

A recent analysis of the whereabouts on the Lake of our KLA membership produced the following results:

163 Members – Kash Lake Road and Lane including all lanes off this Road/Lane – i.e. the southern shores of the lake together with south eastern shore of Mitchell's Bay.

69 Members – Myers Cave Road including all lanes off this Road – i.e. the western end of Mitchell Bay and the western shore of the channel up to and including the western shore of Whitefish Bay and Whitefish Rapids.

57 Members – Tower Lane and all other lanes off this Lane – i.e. the north western section of the Lake including the north-eastern shores of Mitchell Bay, Whitefish Bay, the channel linking the two (east shore), and the rest of Tower Lane east to the "Cliffs".

35 Members – Flieler Lane, Brown's Bay and South Road areas – i.e. the north shore of the lake.

26 Members – Smith Road including all lanes off this Road – i.e. the Eastern section of the Lake, also referred to as Weiss Point.

13 Members – Two islands of Mitchell's Island and OPP Island.

24 Members – Unknown addresses – probably most are on South Kash Lake Road.

Lake Planning Survey Results (Continued from Page 1)

Where we are in the process

It was reported that after a full year of dedicated committee work we're making good progress in the first phase in this multi-year effort.

Key Accomplishments - July 2011 to July 2012

- 1. Compiled 15 pages of research for the draft State of the Lake report
- 2. Completed Community Survey (Dec 2011)
- 3. Completed Business Survey (April 2012)

Note, the committee has only spent \$125 to date, of its \$1,000 budget which covered the cost for the online survey.

Research Underway

Volunteers are currently researching for the draft *State of the Lake Report* in the following areas:

- Hydrology and Water Levels
- Shoreline, Water Quality, and Aquatic Life
- Septic Systems
- Fishing
- Flora, Fauna, and Wildlife
- Crown Land and Severances
- Commercial Activity
- Development, Logging, and Cottage Growth
- Boating, Buoys, and Safety
 Issues
- **Social History** is approximately 50% complete but there is much, much more to do. This is a significant investment, and will be ongoing even after the State of the Lake report is completed. Volunteers are always needed to help out in this effort. So far we have three people working in this area and many more are welcome!

Survey Results


Scott also shared the highlights of the Community and Business surveys. The community survey went out to KLA members and the community at large. 170 responses were received between July and December 2011. In an effort to reach as many people as possible it was distributed in person, through the KLA website and Facebook page, via email with an online link to the survey and promoted through an article which appeared in the North Frontenac News on Sept 29, 2011.

Upon the first review of the data the committee realized that more business participation was needed to ensure we had a good snapshot of the community. This resulted in a specific business survey in April 2012 which was conducted as a telephone interview with over 30 local businesses serving the KLA membership.

Key Findings

About the Community Survey Participants:

It comes as no surprise that the Lake Kashwakamak community is made up of mostly long-term residents and visitors. 88% are owners or family of a place on or near the lake. 80% reported staying at a seasonal cottage, 17% at a permanent home and 3% at a lodge resort. The average number of years respondents have been visiting and/or living at the lake is 29.

Use of Lake:

The top 5 activities that respondents indicated they participate in while at the lake:

- 1. Swimming (95%)
- 2. Reading (87%)
- 3. Boating (85%)
- 4. Nature appreciation (77%)
- 5. Canoeing (75%)

Values (weighted score):

The top 5 values that respondents identified as adding to their personal enjoyment of the lake:

- 1. Clean, clear water (503)
- 2. Peace and Tranquility (460)
- 3. Recreational Enjoyment (455)
- 4. Appreciation of Wildlife, Birds, etc. (446)
- 5. Retention of Crown Land (428)

Issues/Concerns (weighted score):

The top 5 issues/concerns identified as impacting negatively on the enjoyment of their time at the lake:

- 1. Personal Water Craft (498)
- 2. Boat Traffic (459)
- 3. Fish Depletion (383)
- 4. Weeds/Algae (379)
- 5. Daytime Noise (372)

Business Survey Results

In April 2012, 38 businesses were selected for the survey based on information provided by North Frontenac Township. We had an excellent 82% response rate with 31 businesses participating. These businesses represented a good cross section and included retail, construction, accommodation, services, and forestry. Of interest is the fact that 74% of the businesses surveyed want to be kept updated on the Lake Sustainability Plan. We want to thank Peter Burbridge, Jim Pedersen and Darryl Simpson for taking the time to call these businesses and get their feedback.

About the Business Survey Participants:


It's interesting to note that 73% of businesses have operated more than 20 years and the 31 businesses employ 130 people full time. 50% of busi-

ness owners use our lake for recreation and report that their business is very seasonal, with a peak in summer.

Values:

The top values that businesses identified:

- 1. Customers (75%)
- 2. Good roads to customer's property (7%)




Summary Comments:

It was noted during the conversations that several businesses may close this year. They also brought up the point that local business is competitive and encourage cottagers to ask if they're seeing a better deal in the city because they can probably match it. Of interest as well is the fact that local businesses offer delivery of products as well as on-site service.

MVC Provides Student to Help the Lake Sustainability Plan

In late spring the Mississippi Valley Conservation Authority (MVC), applied for a grant from Valley Heartland to assist in the cost of hiring a Lake Planning Research Intern for a 6 month placement. Valley Heartland covers 75% of the wages and MVC makes up the rest, including incidentals. Alyson Simon with MVC, received approval in June and in mid-July they hired Natasha Wright, a graduate from University of Windsor in their Environmental Sciences Program. Natasha will be working with the MVC until the end of the year on both the Mississippi Lake Plan and the Kashwakamak Plan.

Natasha will be helping with the first phase which includes preliminary background data collection and research and assisting the committee in producing the background "State of the Lake" Report. This report will present all the available background information and data about the environmental condition of the lake and surrounding area.
