Water Levels and Healthy Shorelines

Healthy shorelines are vital to maintaining the overall health of our lake. Shorelines help filter pollutants, protect against erosion and provide habitat for fish and other wildlife. Making even small changes can have positive impacts on the health of your property and water quality, thus protecting your investment. It is important to note that the first 10 to 15 metres of the waterfront are responsible for 90% of lake life, which is born, raised and fed in these areas. You can learn what you can do through MVCA and FOCA websites along with many other resources on the

in the lake. It was mentioned on our Facebook page and I want to restate it here again about the effects of boat wakes. Darryl Simpson our loon watch coordinator mentioned the wake impact at our Annual General Meeting. Boat wakes do effect the shoreline erosion, nesting loons, docks and people's ability to enjoy their property. Please do the right thing and stay well away from the shore. Do your boating and water activities in open areas away from cottagers and other boaters.

There was unseasonably high water which has played havoc with our nesting loons. There were NO sightings or reports of eggs or fledglings on our lake making 2015 a very unproductive year.

Sightings of loons in groups of five or more usually suggest the males without mates are gathering for get-

togethers (stag parties). Sadly, this year likely will be one of the least productive seasons for our Kashwakamak Lake loons on record!

Lake Steward's Report - Peter Johnson

Hello fellow Kash lake lovers. What a great summer to be on the lake. It's an amazing place to spend time with friends, family and fellow cottagers.

I would like to thank Milt Houle for taking me out and showing me the ropes (it was nice to hear about his grandkids too). He's a great guy and an asset to have on the lake. Thanks for the years of lake stewardship.

We started coming up regularly in April. We saw birds such as hooded mergansers and buffleheads in our bay during ice out as gust and a peak water level of well as the ubiquitous (had to look up the spelling) loons, blue herons and ever soaring turkey vultures. Later in the summer we

saw at least one of the eaglets flying about the conifers in Simpson's and Levis bays. Later on a group of common mergansers started coming around our dock torturing my retriever.

As of April 19th we were able to get

an aluminum boat with the aid of 25 hp outboard around and through the ice flows so I assume it was completely off within a couple of days (Spring tradition and we use Steve's boat).

Water Levels

Of course the crazy water levels were a popular subject of conversation, from the extreme low levels in the spring to the consistently high levels throughout the summer. The low level causes were in the spring letter.

Judy McIntyre our KLA VP, contacted the Mississippi Valley Conservation Authority regarding the

of Kash lake level. Unfortunately unknown to the MVCA the Mazinaw level reading was 10 cm low. All this caused a delayed response to the heavy rains in Authe lake occurred on Aug 25th. They are looking into preventing this situation in future.

July. On Sept 6 I recorded 25 C which is great for this time of year and still nice for swimming. Water visibility averaged between 5 and 6m throughout the summer which seems to be typical for our lake. Water clarity is determined using the SECCHI method. It consists of lowering a black and white disc into the water until it disappears. In my opinion it is a coarse method of determining water clarity as the reading can be affected by time of day,

cloud condition, waves and how late I stayed up the night before.

I haven't been able to get the phosphate results from the samresponse was that ples I took this spring. I will include them in the spring letter. Phosphate levels of greater than 10ug/l can cause algae blooms which our lake is currently not at risk of but we must be vigilant. Phosphate sources such as fertilizers, septic systems and grey water are all under our control so we can have a direct impact on the health of the lake.

Darryl Simpson also spoke to members about the Loon Watch program and the importance of responsible boating (no wakes near the shores, staying away from loons etc.) to help our loon population.

Many KLA members are concerned about the increased policing on the lake. The KLA invited the OPP for an open question and answer session but the marine officer was unable to come at the last minute due to a family emergency. President Gord Hunter suggested that people forward their questions to him and he will forward them on to the OPP. We are hoping to have them back in 2016.

Mayor Ron Higgins was able to attend at the last minute and he updated membership on what has been happening since he was elected Mayor in the fall of 2014. The first thing on his agenda was a review of the Strategic Plan for the Township. He has also set up a Community Police Advisory Committee which has quarterly meetings. He also spoke at length about the wind turbine project and the Township's position on this. He urged members to stay in contact with the township and voice their opinions and concerns. The Township's position and response is on their website, www.northfrontenac.ca (Please see the in-depth interview the KLA had with Mayor Higgins on p. 16).

President Gord Hunter announced that the KLA is looking for someone to take on the role of Secretary for the Association. This position is not time intensive. 

KLA Lake Sustainability Planning Update

The KLA Lake Planning Committee met in early October to review the *draft Lake Sustainability Plan*. There is still some work to do over the winter to get it ready for the public. The plan is to have it ready in the spring/early summer and share it with KLA members and the lake community. The public will have the opportunity to provide feedback and ask questions at next summer's AGM on July 9th.

Your Questions Answered: Septic Re-Inspection Program

This past season the KLA's president received the following question from one of its members:

"I got a notice in the mail about manual inspection of septic systems (although I can't recall what I did with it). Is this mandatory for all cottagers on the lake even if it was permitted and approved less than 20 years ago?"

We reached out to Eric Kohlsmith at the Mississippi Rideau Septic System Office for an answer. Here's what he told us:

The current re-inspection program is **voluntary**. A property owner needs to contact our office in some manner to participate. We do NOT inspect properties that have not contacted our office.

Properties are selected by the Township based on the following criteria:

No record of a sewage system
The sewage system is 10 years or older
The property is waterfront

All 5 Classes of sewage systems are inspected – outhouses/composting toilets, grey water pits, cesspools, septic tank and leaching filed and holding tanks.

New Website coming soon!



North Frontenac - Interview with Mayor Ron Higgins

Interview on September 29, 2015

Sue MacGregor, KLA's Director of Communications, interviewed Mayor Ron Higgins by telephone in late September in order to introduce the new mayor to our lake community. Here's a transcript of the conversation.

What's your vision for North Frontenac? Where do you see it in 10 years from now?

"10 years from now I'd like to see more economic development and more businesses prosper here. The focus is the 'unique and pristine environment' which includes anything that supports the cottage industry and the tourist industry such as outdoor camping, any outdoor sports-related activities and the arts and crafts industry. So the short answer is I would like to see our economy become more prosperous in the coming years. We have a plan to get there but it will take a lot of work.

We would also like to have more full time residents move into the area. To do that we need the accommodations and the support network to support them - either the economic development or they want to start retiring here. We've been tossing around ideas that we will put in an action plan over the next couple of months so we can move forward."

How will you measure success?

"We know the number of full time and seasonal residents right now so we have a benchmark. That will be one barometer we can use. We also have a listing of all the current businesses so we can measure the number of new businesses on there and hopefully track the number of new visitors through them as well which would be another barometer. Taxation is another barometer by either generating more tax revenue from businesses and hopefully keep residential taxation in check."

Your background in the area was through the NF Lake Association Alliance. What do you believe the role and importance is of lake associations to the township?

"It's a huge importance, especially with the amount of downloaded services that are happening as we speak. I'm referring to the Ministry of Natural Resources who are looking at reducing the amount of dollars they are using to sustain the conservation authorities and putting more burden on municipalities to support the conservation authorities. With that the lake associations are very in tune with the environment and the lands around the lake. As a result, as you are doing on your lake, you are measuring water quality, ice in and ice out etc. and keeping a good watch on your lakes. That's going to be crucial going forward as we look at our official plan and how we do development in and around lakes. What's the capacity on lakes? What we should or shouldn't be doing. So we will be going to Lake Associations for data going forward for our planning when we do these things."

Recently it was reported that council has spent a good deal of money hiring consultants to look at office space and potentially build a new facility at great cost to the taxpayers. Where does this proposal stand?

"Those studies were done in years past. We haven't done any new studies under the new council. We haven't spent a cent on this so far. ... Before we make any decisions we need to understand all the facts. That's what we are doing right now - getting the facts and understanding



what we're dealing with. As far as a new building goes, there is no decision yet and there won't be one made this year. There are other options that we need to keep in mind as well. If the school closes we won't need a new building. Some of the information that got out into the public were not factual. I will write a year-end report to set out the facts for issues like this."

We know that the cost of policing is increasing at a great rate and that cost has been downloaded to the municipalities. Have you looked at what would it cost for NF to have its own policing and/or more efficient and effective service?

"Yes. North Frontenac put up a proposal to do an in-depth report on police costing and it came back last month. It is at least 2 times the cost of what we're paying the OPP for our current service. We closed the door on putting in our own police service at this time as the best value appears to be with the OPP."

You already mentioned the level of taxation and it is always of concern to rate payers and cottage owners. As you know, cottage owner/seasonal residents pay the majority of the property taxes in North Frontenac and account for 70% of the dwellings. We have heard from a good number of our KLA members that they are not pleased with the continued hike in property taxes – 40% since 2009.

There are around 2,000 full time and 6,000 seasonal residents which means seasonal residents pay about 70% of the taxes. When this Council did its first taxes our actual rate for NF is exactly the same as last year even with the increased cost for OPP coverage. We reduced costs in other areas to compensate for the increase in OPP costs. It was the impact of the assessments that increased taxes for some people. It had nothing to do with North Frontenac. ... The NF mill rates were exactly the same as last year."

What is the status of the proposed wind energy project? What impact might it have on North Frontenac and Kashwakamak Lake?

As your association is aware, I sent in my position paper on where we stand. I also sent a letter to the Premier stating why NextEra should not be selected as a proponent for wind energy based on them not meeting some of the mandatory requirements that were spelled out in the Clean Energy Act. All the proponents are being assessed as we speak so the status will be announced in late October or early November. Even though we've put it out there as to why they shouldn't come here, with the Clean Energy Act as it is written, it overrides our master plan and they could go ahead. If it does I will fight this even after a decision is made if they decide to come in to North Frontenac. Having said that, because we are an "unwilling host" to wind mills I am entertaining the thought of doing solar farms on unused properties, closed waste sites, brown fields, old gravel pits, crown land – areas that won't have an impact on any of the residents, full time or seasonal. If we're successful at that it will help generate some money to help to pay for some of the infrastructure requirements we have versus through taxation. We would have opportunities for funding through vibrancy funds and doing it in a cohesive way and not being mandated to do it.

Any final words for us today?

I'm pleased with all the feedback I received on what I've done to date. I know I don't please everybody but I think the majority of people think I'm on the right track. I really do appreciate all the feedback I get from residents.
