Eurasian Milfoil

I indicated in the spring newsletter that my son and I were going to take aerial photos of the Eurasian milfoil at different locations on the lake to determine if the situation is worsening. Unfortunately, due to unforeseen circumstances, we weren't able to do so. We plan on doing it next summer.

Hazard Markers

Notice re: KLA Low Wake and Hazard Markers



Each spring, and throughout the season, on behalf of the Kashwakamak Lake Association (KLA), Low Wake and Hazard Markers are placed, and/or checked around the lake in an effort to mark some of the lake's shoals, rocks, boulders, narrow passages etc. While best efforts are made to mark the most hazardous areas, it is not realistic to be able to mark everything, especially in areas that are close to shore or have little boat traffic.

- It is critical that boaters realize that these **MARKERS** are **NOT** navigational buoys. Instead, the markers are intended to call attention to **SOME** of the lake's hazards.
- **EVERY** individual operator of a watercraft is solely responsible for safe boating, including the avoidance of any marked or unmarked water hazards.
- While we try to identify and mark hazards, the KLA is not responsible for ensuring all hazards are marked, or continue to be marked.

North Frontenac Strategic Plan

Thank you to all who completed the online survey or attended an in-person session to provide input to the Township of North Frontenac Strategic Plan. For your awareness, the North Frontenac Lake Association Alliance (NFLAA), in their meeting with the consultant supporting the council in developing the updated Strategic Plan, stressed the importance of maintaining our pristine waterways and natural landscape. Further, NFLAA also pointed out to the consultant the *absence of any mention of lakes or waterways in the public survey* (which I am sure many of you noted as well)! We will provide further information on the Strategic Plan update as it becomes available.

A Reminder and a Request - Help Us Preserve our Dark Sky Status

As many of you are aware, North Frontenac was the first community in Ontario to receive a Dark Sky designation. Light pollution negatively impacts wildlife and ecosystems, energy and climate, human health and Night Sky Heritage. <https://darksky.org/resources/what-is-light-pollution/>

How you can help

- ⇒ For many of you as you close up your cottage for the season, please remember to douse all lights - inside and outside - including all solar lights.
- ⇒ For those who are remaining “North of 7”, please respect our lake wildlife and ecosystems, your neighbours and the North Frontenac Light Bylaws. *Outdoor lighting should be fully shielded and light down where it is needed, not into the sky.* Fully shielded fixtures can provide the same level of illumination on the ground as unshielded ones with less negative impact on the environment.
- ⇒ When not required for safety, please turn off your outdoor lights so that all wild and non-wildlife can enjoy our beautiful dark skies!

Positive Changes to Recycling Protocols at North Frontenac Waste Sites

Effective October 10th, North Frontenac has adopted a **Two Stream Recycling System**. This means less sorting of recyclables:

- ◆ Glass can now be placed in the bin with plastic containers and cans. There is no longer a need to separate these items.
- ◆ Corrugated cardboard can now be placed in the paper and box board bin.

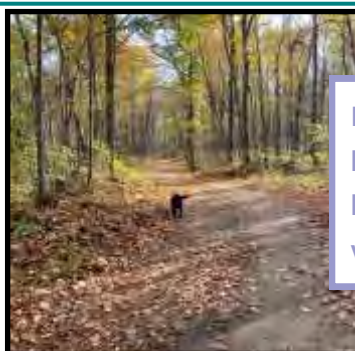
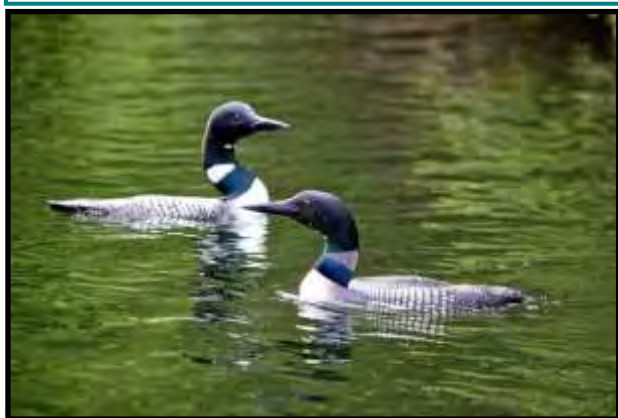

Have a safe and wonderful fall and winter season. I look forward to seeing and meeting many of you in 2024!

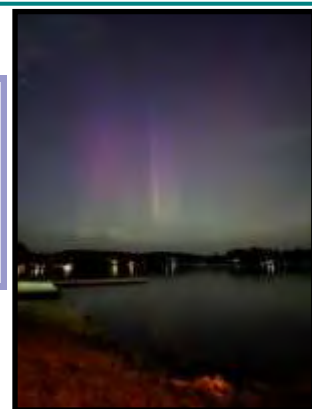

Woodcrest owner Kyle Jenkin also presented. He shared his family’s history as lake property owners, their belief in lake stewardship and working with local councils. He provided an overview on where they are with their property, and outlined the steps they’ve already taken to remediate their shoreline using the information they had from their property’s **Love Your Lake 2020 Shoreline Assessment**. He and his brother Morgan worked with the Mississippi Valley Conservation Authority (MVCA), the Ministry of Natural Resources and Forestry (MNRF) and the Township of North Frontenac (including the Fire Department), to attain all necessary permits, and make adjustments to roads and drainage in order to do their rip rap shoreline upgrade. He reported that it was a smooth process all in all.

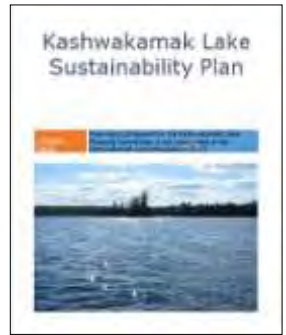
Save the date for next year’s AGM

UPDATE: Kashwakamak Lake Dam Environmental Assessment

The Mississippi Valley Conservation Authority (MVCA) is conducting an Environmental Assessment study of the future of the Kashwakamak Lake Dam, and requested initial public input by June 23, 2023. In response, the KLA board submitted a letter emphasizing the importance of this dam for the lake community and setting out our three priorities: maintaining the current level of the lake during the recreational period, minimizing disruption during the off-season construction period, and keeping the KLA informed and involved. The study team has acknowledged our priorities and indicated that they will be forming a Citizens Liaison Committee (CLC), which will include representation from the KLA.

Over the summer, the KLA discussed this study and our three priorities with members at the July AGM and members of the Weiss Point Road Association, and also informed the broader lake community through our Facebook group and the Membership Recruitment letter we sent out in August. We also appointed two directors, Alan Dean and Andrew Johnston, to act as our liaisons with the MVCA and its consultants, and put their names forward as members of the CLC.

We understand that fieldwork for the study has been completed and that the composition of the CLC will be announced shortly. The CLC will meet twice, once this fall and again over the winter, to receive an overview of the study and consider proposed solutions and design alternatives. There will also be opportunities for direct public input through Public Information Centres to be set up before the year-end.


